POTENTIAL EXPOSURE, BUT NO SYMPTOMS

If you have been potentially exposed to COVID-19 & you are not showing symptoms, **BEFORE**REPORTING TO WORKSITE:

IF DIRECTED TO SELF-QUARANTINE

- Notify your supervisor ASAP & provide status
- If possible, provide documentation via e-mail, but not later than return
- Supervisors will designate employee status as "QUARANTINED-IR" in CMD PAAS
- Civilian employee time card will be annotated as "LN/PS" (Weather and Safety Leave) for the period





Employees who call in sick will be asked the following questions:

- HAVE A COUGH
- **☑** DIFFICULTY BREATHING?



at least two of these symptoms

- FEVER CHILLS HEADACHE
- REPEATED SHAKING WITH CHILLS
- **☑** MUSCLE PAIN **☑** SORE THROAT
- **☑** NEW LOSS OF TASTE OR SMELL

ANSWERS "YES" TO ANY QUESTION

- Call your licensed medical authority
 - Active duty: DIRECTED to seek medical care & will not return to work until cleared by medical personnel
 - Civilian or contractor: ENCOURAGED to seek medical care & will not return to work until cleared by medical personnel
- Supervisors will designate employee status as "SICK-IR" in CMD PAAS



ANSWERS "NO" TO ALL QUESTIONS

- Supervisors will designate employee status as "SICK" in CMD PAAS
- All personnel will be encouraged to seek medical care & will not return to work until free of all symptoms or cleared by medical personnel





EMPLOYEE SHOWS SYMPTOMS AT WORK

If at work, and you feel feverish, OR have a cough, OR difficulty breathing, you should don a mask & notify your supervisor IMMEDIATELY.

- Call your licensed medical authority
 - o Active duty: DIRECTED to seek medical care & will not return to work until cleared
 - Civilian or contractor: ENCOURAGED to seek medical care & will not return to work until medically cleared
- Supervisors will designate employee status as "SICK-IR" in CMD PAAS
- After 1500: NOTIFY the Command Surgeon (J080) org box stratcom.offutt.j080.list.j080users@mail.mil
