The USSTRATCOM Inspector General (IG) does not accept complaints that do not involve a USSTRATCOM member/interest or complaints for which other grievance or appeal channels established by law, rule, or regulation, provide a remedy or redress of adverse actions.

The following issues are not normally appropriate for an IG; however, the IG maintains discretionary authority to review the issues listed.
